Tournament will be played under the TSA rules. The TSA Code of Conduct applies. 2. Only recognised tennis apparel will be permitted. 3. No coaching or assistance from parents or coaches will be tolerated. 4. Do not enter if you are unable to play on the stipulated dates for both trials and tournament. 5. Format will be dependent on number of entries received. 6. Everyone can play trials and be selected for teams provided they are at school in South Africa. Only pupils schooled in the Gauteng Central province may participate in the trials and be eligible for selection. 7. No entries will be accepted <u>without</u> proof of payment. 8. No entries will be accepted after the closing date. 9. If you are selected for a team further expenses will be involved. 10. The TSA 2021 SA High Schools Tournament (u15/19) will be held in Pretoria from 19 – 21 March 2021 (travelling on 18 March). 11. Please note that 2 players of colour will be selected per team. 12. Players who are unable to attend trials due to the fact that they will be representing South Africa at the time of trials may still be selected for the team. 13. B sides will be selected as reserves but with no guarantee that they will participate in the interprovincial tournament due to ranking and the availability of space at the tournament. The final decision is made by Tennis South Africa and not Gauteng Central Tennis Association. 14. In the event of rain, the committee will make alternative arrangements.
